PETITION TO SET ASIDE THE NOMINATION PAPER OF NATE CURTIS

Petitioners, by and through their undersigned counsel, file this Petition to Set Aside the Nomination Paper of Nate Curtis, and further request this Honorable Court direct appropriate officers of the County of Dauphin, Commonwealth of Pennsylvania, and its political subdivisions, to omit the name of Nate Curtis from the ballot for Mayor of Harrisburg the municipal election occurring November 5, 2013. In support thereof, Petitioners respectfully represent as follows:

PARTIES AND STANDING OF PETITIONERS

1. Petitioner Autumn L. Cooper is an adult individual who resides and is registered to vote, as an enrolled member of the Democratic Party, at 2224 Green Street, City of Harrisburg, County of Dauphin, Commonwealth of Pennsylvania (hereafter, "Petitioner Cooper"). As such, Petitioner Cooper has a direct and substantial interest in the conduct of, and compliance with laws governing, the November 5, 2013 election for the office of Mayor of the

City of Harrisburg. Therefore, Petitioner Cooper has a direct and substantial interest in the success of this Petition. *See generally, In Re: Barlip*, 428 A.2d 1058, 1060 (Pa. Cmnlth.1981).

2. Petitioner Joseph K. Lahr is an adult individual who resides and is registered to vote, as an enrolled member of the Republican Party, at 1037 South 18th Street, City of Harrisburg, County of Dauphin, Commonwealth of Pennsylvania (hereafter, "Petitioner Lahr"). As such, Petitioner Lahr has a direct and substantial interest in the conduct of, and compliance with laws governing, the November 5, 2013 election for the office of Mayor of the City of Harrisburg. Therefore, Petitioner Lahr has a direct and substantial interest in the success of this Petition. *Id.*

JURISDICTION

3. The Court of Common Pleas of Dauphin County, Pennsylvania has original jurisdiction over this election matter pursuant to 42 Pa.C.S. § 931 and 25 P.S. § 2937.

4. The act of June 3, 1937 (P.L. 1333, No. 320), as amended, known as the Pennsylvania Election Code (25 P.S. § 2600 *et seq.*) (hereafter, the "Election Code") and relevant other statutes, as well as case law decided pursuant thereto, govern disposition of matters addressed by this Petition.

QUALIFYING FOR THE MUNICIPAL ELECTION BALLOT

5. Under Pennsylvania law, the City of Harrisburg is classified as a city of the third class. Therefore, the City of Harrisburg is governed by the act of June 23, 1931 (P.L. 932, No. 317), as amended, known as the Third Class City Code (53 P.S. § 35101 *et seq.*) (hereafter, the "Third Class City Code"). *See* 53 P.S. §§ 101, 35101 and 35107.

6. As a baseline for candidates and officeholders, the Third Class City Code sets forth specific minimum qualifications for individuals permitted to be elected and serve as Mayor of Harrisburg. *See* 53 PS § 36201.

7. The Third Class City Code also mandates that elections relating to all officers of third class cities, including Mayor of Harrisburg, shall be conducted in accordance with the Election Code. *See* 53 P.S. § 35703.

8. Pursuant to the Election Code, an election for the office of Mayor of Harrisburg will be conducted on November 5, 2013 (hereafter, the "2013 Municipal Election"). *See* 25 P.S.

§§ 2752 and 2754; *see also* Constitution of the Commonwealth of Pennsylvania, Article VII, Section 3.

9. In addition to qualifying by nomination of a political party, an individual seeking to be listed as a candidate on the Municipal Election ballot may circulate, complete, sign, and file a nomination paper with the appropriate elections supervisor. The Election Code specifies the requirements for the content, circulation, signing, and filing of nomination papers for candidates of a political body in the Commonwealth of Pennsylvania. *See* 25 P.S. §§ 2911 and 2912.

10. The nomination paper to be filed by an individual seeking placement on the Municipal Election ballot requires submitting a sufficient number of valid signatures and additional information provided by qualified electors, as well as an affidavit completed and signed by the candidate. *See* 25 P.S. § 2911.

11. Each page of a nomination paper which includes signatures of eligible voters (hereafter, "Signature Page") is comprised of two sides requiring candidates for Mayor of Harrisburg, before circulation, to: (a) name the political body nominating the candidate; (b) identify the county of signers; (c) provide candidate information (office, district, name of candidate, place of residence, and occupation); and (d) designate a committee to fill vacancies. *See* 25 P.S. §§ 2911 and 2912

12. Each Signature Page also includes: (a) thirty-five (35) lines designated for obtaining necessary information from electors (signature, printed name, place of residence, and date of signing); and (b) a notarized affidavit requiring certain information of a qualified elector (signature, printed name, place of residence, and county of signers) circulating the Signature Page. *Id.*

13. Circulation of a nomination paper and its subsequent filing with the Dauphin County Bureau of Elections and Voter Registration (hereafter, the "Elections Bureau") was limited to the time period commencing March 13, 2013 and concluding August 1, 2013. *See* 25 P.S. § 2913.

14. Appended to the nomination paper, a candidate must submit an affidavit by the candidate stating: (a) the election district where he resides; (b) the name of the office sought; (c) that he is eligible for the office sought; (d) that he will not knowingly violate the Election Code or engage in corrupt practices; (e) that he has not been a candidate otherwise; (f) that he was not a member of a recognized political party since at least thirty (30) days before the primary

election; (g) that he does not already hold the office he seeks, but which expires at another time (hereafter, the "Political Body Candidate's Affidavit"). *See* 25 P.S. § 2911 (e).

15. In addition to the Political Body Candidate's Affidavit, a candidate also must file a statement of financial interests covering the preceding year (hereafter, "Statement of Financial Interests") with the nomination paper by no later than the last day for filing the nomination paper. *See* 65 Pa.C.S. § 1104.

16. In accordance with Pennsylvania law, unless a candidate is eligible for the office sought and the requirements set forth in the Election Code are satisfied, the candidate's name may not be listed on an election ballot by virtue of an incomplete, insufficient, and invalid nomination paper containing material omissions, errors, or defects.

OBJECTIONS

17. On or about June 18, 2013, Nate Curtis (hereafter, "Mr. Curtis") filed with the Elections Bureau two (2) Signature Pages, purporting to include 65 signatures of electors, and a Political Body Candidate's Affidavit. On or about June 24, 2013, Mr. Curtis filed with the Elections Bureau two (2) additional Signature Pages, purporting to include 51 signatures of electors, and a Name Change Request. On or about July 29, 2013, Mr. Curtis filed with the Elections Bureau a Statement of Financial Interests. On or about July 31, 2013, Mr. Curtis filed with the Elections Bureau two (2) additional signature pages, purporting to include 37 signatures of electors. Collectively, such filings by Mr. Curtis constitute his nomination paper for the office of Mayor of Harrisburg (hereafter, "Nomination Paper"). The Nomination Paper is attached hereto, and incorporated herein, as Exhibit A.

18. Original versions of the Nomination Paper (including the Signature Pages, Political Body Candidate's Affidavit, and Statement of Financial Interests) were filed with, and remain in the custody of, the Elections Bureau and are incorporated herein by reference.

19. The Nomination Paper purports to render Mr. Curtis a candidate for the office of Mayor of Harrisburg at the 2013 Municipal Election. *See* 25 P.S. § 2936.

20. Pursuant to the Election Code, individuals objecting to the nomination paper of a candidate must, within seven (7) days after the final day for filing nomination papers, file a petition to set aside with the appropriate court. *See* 25 P.S. § 2937.

21. As set forth herein, Petitioners file this Petition to Set Aside Nomination Paper of Nate Curtis based on objections to numerous fatal defects related to matters of eligibility, the Political Body Candidate's Affidavit, and Statement of Interests included in the Nomination Paper. Petitioners thereby pray this Honorable Court set aside Mr. Curtis's asserted nomination and provide relief based on the specific grounds set forth below.

A) Mr. Curtis is Ineligible to be Elected or Serve as Mayor of Harrisburg

22. Petitioners and their representatives have reviewed the Nomination Paper and applicable Pennsylvania law. Based upon such review, Petitioners believe, and therefore aver, that the statutory language of the Third Class City Code and an inaccurate, insufficient, and invalid Political Body Candidate's Affidavit render Mr. Curtis ineligible to qualify for inclusion as a candidate for Mayor of Harrisburg on the 2013 Municipal Election ballot.

23. The Election Code requires that a valid nomination paper include "an affidavit of each candidate nominated therein, stating ... (3) that he is eligible for such office." 25 P.S. § 2911(e).

24. On or about June 18, 2013, Mr. Curtis completed, signed, and filed a notarized Political Body Candidate's Affidavit averring: "I do swear (or affirm) ... that I am eligible for said office ... I swear (or affirm) to the above parts as required by the laws applicable to the office I seek." *See* Exhibit A, Political Body Candidate's Affidavit.

25. Mr. Curtis, however, is not eligible be elected or serve as the Mayor of Harrisburg.

26. To be eligible for the office of Mayor of Harrisburg, a candidate must be a resident of the City of Harrisburg for at least one (1) year before election to the office. *See* 53 PS § 36201.

27. Upon information and belief, Mr. Curtis was not a resident of the City of Harrisburg for at least one (1) year before the 2013 Municipal Election. *See* Exhibits B and C.

28. Mr. Curtis was a resident and registered to vote at 9 Stone Spring Lane, Township of Hampden, County of Cumberland, Commonwealth of Pennsylvania until April 19, 2013, less than one (1) year before the 2013 Municipal Election. Public voter registration and voting history information for Mr. Curtis is attached hereto, and incorporated herein, as Exhibit B.

29. Mr. Curtis did not register to vote in Dauphin County until April 19, 2013, less than one (1) year before the 2013 Municipal Election. *See* Exhibit B, page 2.

30. Upon information and belief, Natalie L. Curtis (hereafter, "Ms. Curtis"), an individual with whom Mr. Curtis previously shared a residence in Hampden Township (Cumberland County) and with whom he currently shares a residence in the City of Harrisburg (Dauphin County), also was a resident and registered to vote at 9 Stone Spring Lane, Township of Hampden, County of Cumberland, Commonwealth of Pennsylvania until April 19, 2013. Public voter registration and voting history information for Ms. Curtis is attached hereto, and incorporated herein, as Exhibit C.

31. Moreover, Ms. Curtis voted at her assigned polling location in Hampden Township (Cumberland County) in the general election that occurred November 6, 2012, less than one (1) year before the 2013 Municipal Election. *See* Exhibit C, page 3.

32. Mr. Curtis's representation and notarized affirmation that he is eligible for the office of Mayor of Harrisburg is a purposeful and inaccurate attestation made in bad faith and presented in a manner intended to mislead and/or deceive voters and the Elections Bureau.

33. Therefore, because Mr. Curtis fails meet the eligibility requirement set forth in the Third Class City Code and Mr. Curtis's Nomination Paper fails to comply with the Election Code, it should be set aside by this Honorable Court.

B) Mr. Curtis's Failure to Identify a Committee to Fill Vacancies Renders It Invalid

34. Petitioners and their representatives have reviewed the Nomination Paper and applicable Pennsylvania law. Based upon such review, Petitioners believe, and therefore aver, that the failure to include a Committee to Fill Vacancies on any, let alone all, of the Signature Pages renders the Nomination Paper fatally incomplete, insufficient, and invalid.

35. The Election Code requires that a valid nomination paper include: "(d) the names and addresses of the committee, not to be less than three (3) nor more than five (5) persons, authorized to fill vacancies, if any shall occur." 25 P.S. § 2912.

36. Pursuant to the Election Code mandate, each page designed for gathering signatures of eligible electors includes a section specifically designated for, and limited to, identifying a "Committee to Fill Vacancies." *See, e.g.,* Exhibit A, Signature Pages 1-6, Section C.

37. A Committee to Fill Vacancies must be established and listed on a nomination paper prior to circulation and filing. A Committee to Fill Vacancies must be listed on each and

every page of the nomination paper. As this is not a mere technicality, the failure to include a Committee to Fill Vacancies on a signature page renders it incomplete and invalid. *In re: Nomination Papers of Jack F. Dunmire*, 940 A.2d 538 (Pa. Cmwlth. 2007).

38. As applied to Mr. Curtis's Nomination Paper, exactly zero (0) of the six (6) Signature Pages include a sufficient "Committee to Fill Vacancies." In fact, the section for "Committee to Fill Vacancies" on all six (6) Signature Pages was circulated and filed blank. *See* Exhibit A, Signature Pages 1-6.

39. As a result, each Signature Page omitting a Committee to Fill Vacancies is incomplete, invalid, and the signatures contained therein must be stricken.

40. Therefore, because Mr. Curtis's Nomination Paper included zero (0) signatures from valid electors on complete Signature Pages which included the identification of a Committee to Fill Vacancies, as required by law, all signatures included in Mr. Curtis's Nomination Paper must be stricken.

C) Mr. Curtis Filed a Defective Statement of Financial Interests

41. Upon information and belief, Mr. Curtis disregarded the requirements imposed by Pennsylvania law by filing an incomplete, inaccurate, and false information on Block 9 (Creditors) and Block 10 (Direct or Indirect Sources of Income) of the Statement of Financial Interests. The Statement of Financial Interests is attached hereto, and incorporated herein, as Exhibit D.

42. In his Statement of Financial Interests, Mr. Curtis asserted and affirmed that he did not have any creditors during calendar year 2012. *See* Exhibit D, Block 9.

43. Upon information and belief, Mr. Curtis had at least one creditor to whom more than \$6,500.00 was owed during calendar year 2012. *See* 65 Pa.C.S. § 1105(b)(4).

44. In his Statement of Financial Interests, Mr. Curtis asserted and affirmed that his only source of direct or indirect income during calendar year 2012 was the Pennsylvania Air National Guard. *See* Exhibit D, Block 10.

45. Upon information and belief, Mr. Curtis had at least one other direct or indirect source of income from whom he received an aggregate \$1,300.00 or more during calendar year 2012. *See* 65 Pa.C.S. § 1105(b)(5).

46. As a result, Mr. Curtis's Statement of Financial Interests is inaccurate, incomplete, insufficient, and invalid based on an intention to deceive or conceal.

47. Therefore, because Mr. Curtis's Statement of Financial Interests is required by Pennsylvania law, his Nomination Paper is defective beyond rehabilitation and must be stricken.

48. Pursuant Petitioners' objections set forth herein, the Nomination Paper does not satisfy the requirements necessary to place the name of Nate Curtis on the ballot as a candidate for Mayor of Harrisburg, as required under Pennsylvania law.

49. Therefore, the Nomination Paper should be set aside for failure to satisfy the requirements of the Election Code and the laws of this Commonwealth due to the purposeful misrepresentations made in bad faith with the intent to deceive the electorate and the Elections Bureau. *See* 25 P.S. § 2937.

PRAYER FOR RELIEF

WHEREFORE, Petitioners pray that this Honorable Court enter an Order providing relief as follows:

1. Sustaining Petitioners' objections to the Nomination Paper of Nate Curtis;
2. Setting aside the Nomination Paper of Nate Curtis for the office of Mayor of Harrisburg on the November 5, 2013 Municipal Election ballot;
3. Declaring Nate Curtis did not submit a valid Nomination Paper required by Pennsylvania law to have his name placed on the ballot as a candidate for the office of Mayor of Harrisburg for the November 5, 2013 Municipal Election;
4. Directing the appropriate officers of the County of Dauphin, Commonwealth of Pennsylvania, and its political subdivisions, not to place the name of Nate Curtis, or any derivation thereof, on the ballot as a candidate for the office of Mayor of Harrisburg for the November 5, 2013 Municipal Election;
5. Ordering Nate Curtis and/or his official campaign or candidate's committee to remit payment for the costs of these proceedings, including but not limited to related fees, and other reasonable costs incurred by

Petitioners in bringing this Petition before the Court. *See* 25 P.S. § 2937;
and

6. Granting further or other relief as this Honorable Court deems necessary
and just in the disposition of this matter.

1. IT IS HEREBY ORDERED:

A. Hearing on the Petition to Set Aside Nomination Paper of Nate Curtis is scheduled for _____, in Courtroom Number _____, Harrisburg, Pennsylvania. Petitioners are directed to secure the services of a court stenographer for the hearing. Failure of Petitioners to secure the services of a court stenographer may result in the dismissal of this matter.

B. If signature lines are challenged, Petitioners shall secure, by request or subpoena, the presence of a Statewide Uniform Registry of Electors (SURE) system operator at the hearing.

C. A pre-trial conference may be scheduled at any time after _____.

D. No later than _____, Petitioners shall personally serve a copy of this Order, a copy of the Petition to Set Aside Nomination Paper of Nate Curtis (if the Petition to Set Aside has not previously been served) and, if signature line challenges are at issue, one digital media device (CD or USB Flash Drive) containing the objections in spreadsheet format and a key to the codes used in the spreadsheet, on _____, Candidate, or an adult member of Candidate's family. Objector shall file a proof of service with the Chief Clerk promptly thereafter.

E. Objector shall personally or by registered mail serve a copy of this order on the Dauphin County Bureau of Elections and Voter Registration and promptly

thereafter file a proof of service with the Chief Clerk.

F. At the time of hearing, Petitioners shall offer proof of timely service of the Petition to Set Aside on the Dauphin County Bureau of Elections and Voter Registration.

G. All counsel are under a continuing obligation and are hereby ordered to serve a copy of this Order upon all unrepresented parties, if any, and upon all counsel entering an appearance subsequent to the entry of this Order.

2. It is FURTHER ORDERED:

A. Petitioners shall file a list of all witnesses to be called at the hearing and the *curriculum vitae* and expert reports of all expert witnesses. Any witness not identified shall be precluded from testifying except for good cause shown.

B. Candidate shall file a list of all witnesses to be called at the hearing and the *curriculum vitae* and expert reports of all expert witnesses. Any witness not identified shall be precluded from testifying except for good cause shown.

3. If signature line challenges are at issue, it is FURTHER ORDERED:

A. Petitioners shall immediately make reasonable efforts to arrange to meet with Candidate or Candidate's representative and, if appropriate, with a SURE system operator, to review before the hearing each and every challenged signature line.

B. Petitioners and Candidate shall file a stipulation of the parties that identifies:

- a) the total number of completed signature lines submitted;
- b) the total number of uncontested signature lines submitted;
- c) the total number of signature lines challenged;
- d) each and every signature line to which there is an objection, identified by page number and line number, and the basis for the objection;

- e) each and every signature line to be stricken as invalid or for which an objection is to be withdrawn, identified by page number and line number, if the parties can reach such a stipulation.

C. Candidate shall file a list of all signature lines, identified by page number and line number, that are facially defective and that Candidate intends to rehabilitate. Candidate shall also state the manner in which Candidate intends to rehabilitate the signature lines.

4. Petitioners and Candidate may each file a memorandum of law in support of their respective position by the time and date specified in paragraph 5 of this order. No further memoranda will be permitted unless ordered by the Court.

5. Unless otherwise ordered, all filings required or permitted by paragraphs 2, 3 and 4 of this Order shall be filed with the Court by no later than 12:00 o'clock noon on _____ Parties may NOT file by facsimile or e-mail without express prior permission from the Court.

6. Failure to comply with any provision of this order may preclude the noncompliant party from entering any evidence, and may result in the imposition of monetary sanctions.




